ORDER

In terms of Principal Secretary, Govt. of Haryana, Cooperation Department letter no. 307-C-7-2014/6710 dated 30-05-2014 and in exercise of powers conferred under section 37 of Haryana Cooperative Societies Act, 1984, the Registrar Cooperative Societies, Haryana makes the following rules further to amend the Haryana State Central Cooperative Bank Staff Service Rules (Common Cadre) Rules 1975 namely:-

- 1 These rules may be called the Haryana State Central Cooperative Bank Staff Service (Common Cadre) Amendment Rules 2014.
- 2 In the Haryana State Central Cooperative Bank Staff Service Rules (Common Cadre) Rules 1975 for the following shall be substituted/added as under:-

- a) The person appointed/ recruited through direct recruitment to any post shall have to qualify the State Eligibility Test in Computer Appreciation and Applications (SETC) conducted by any authorized agency approved by Government within the probation period of two years, extended by one year. They shall not be entitled to earn any increment in his pay scale till they qualify the said Test failing which the services shall be dispensed with.
- b) The persons promoted to the posts shall have to qualify the State Eligibility Test in Computer Appreciation and Applications (SETC) within the probation period of one year, extendable by one year failing which they shall be reverted back to the original post. “


